Below are summaries of presentations, significant actions taken by the Board, and a glimpse into the future agenda items, all aimed at furthering our District Strategic Plan goals and mission.

## **Presentations**

- This week was National School Counselors Week, Ms. Melynda Martin, Director of Student Services, provided an
  in-depth look at the ongoing efforts and achievements of our School Counselor Program, showcasing how it
  supports our students' academic and emotional well-being. This aligns to Strategic Plan Goal 1 and 2. The Board
  expressed their gratitude for our counselors for all they do to support our students and appreciated them for
  their work.
- Ms. Tonia Immel, Executive Director of Business Services presented the importance of understanding and
  adhering to conflict of interest laws, emphasizing the integrity and transparency of our operations and shared
  conflict of interest training to the board. Being good stewards of taxpayer dollars is everyone's roles. Each year,
  all Union ESD staff are trained about conflict of interest.

## **Significant Actions**

- The Governing Board approved the 2025-2026 School Calendar, aligning our schedule with the surrounding educational community and ensuring a cooperative approach to our students' learning journey.
- Approval was granted for the Tax Credits Donation for 2023. Tax Credit donations totaled \$8,480.00 for the 2023 tax credit year. Thank you to our community for your generosity and commitment to enhancing our educational environment. Members of the community can contribute Tax Credit donations year round by filling out the Tax Credit form located at each school site's front office or at the District office.
- The Board also moved forward with the approval of contracts and rehire lists across certified, support, and administrative staff for the 2024-2025 school year. This aligns with Strategic Plan Goal 3, to retain and recruit highly effective teachers, leaders, and support staff that commit to meeting the needs of our learners.
