The purpose of the study session was to discuss the 2018-2019 budget and possible compensation increase options. Mrs. Susan O'Rielly presented the Governing Board with the legislature approved increase of funds for school districts. The language within the new funding seeks that districts maximize teacher salary increases with the new funds. Mrs. O'Rielly presented the Board with two options on how Union Elementary School District would like to fund salary increases for both teachers and all other district staff.

A. Susan replied and said that she really could not speak to what and how the legislature rules on budget increases/decreases it is really up to how the state budgets are approved.

## 2018-2019 Budget Study Session

May 17, 2018

The 2018-2019 budget provided Districts an additional \$210.5 per Weighted Student Count with the intent funds would be used to maximize teacher salary increases.

There is not legal restrictions on the funds. This allows local control by school boards regarding usage.

There will be requirements to report our average teacher salary to the public and the state.
