Thanks to our students, families, and employees for their dedication to building relationships and connections with one another. Through our purposeful commitment to Positive Behavior Interventions and Support (PBIS), opportunities for extracurricular and cocurricular activities such as Student Council, Art, Foreign Language, Music, PE, Dance, Soccer, etc. we are providing a well-rounded experience for our students that focuses on not only the importance of education and career, but also the tools to succeed in life, including hobbies & recreation; home & family; and community & service. Next quarter we are looking forward to seeing student performances and opportunities to showcase the various talents our students possess!

I previously shared with the Board, and also want to share publicly, that our DIBLES results are showing that

our commitment to accelerating learning is making an impact. I want to celebrate the following teams: First, Second, Third, Sixth, and Seventh grades are already performing better than students at the same grade level when compared to Middle of the Year (MOY) in 2021-22 and our Fourth and Fifth grade students are nearing last year's MOY 21-22 levels. We are optimistic that this increase is due to 1) our new Reading adoption being used with fidelity; 2) a focus on adherence to our schedules & routines; 3) getting started with our reading program before testing; and 4) reading interventions starting the second week of school. 

A. 2021-2022 Annual Financial Report Presentation-Presentation by Mr. Jeremy Callas

Q: Mrs. Briceno asked about what was the reason the Budget Balance increase?

A: Mr. Callas responded that the reason the budget balance was increasing was due to the ESSER funds being present there are no restrictions on covid funds so those are being used to help support the district expenditures. What you are seeing is you have slightly more revenue that was available this year than what was going on in expenditures and that is because some of these expenditures are being shifted to the ESSER funds. Yes, there is a slight increase but it's a decent balance to have when looking at your overall budget. Usually 20-25% is what's recommended by credit rating agencies.

Q: Mr. Sunn asked what can the Covid funds be spent on?

A: Mr. Callas responded that the Covid funds have little restrictions. These funds are flexible on what they can be spent on. On a national level Legislators are looking for examples on what they can't be spent on because they were intended to be flexible. There are requirements on how you spend the money only because the federal requirements on things such as construction are very different than state requirements. There are different restrictions in terms of the process but no limitations in use.
