Mrs. Morris paused to provide information on what a job order contract is. There's a state-approved contractor list where they go through a rigorous bidding process to be qualified as a state contractor. There is either a state contract or a 1 GPA and they put forth their cost so that you don't have to go through a bid process that might slow down a district our size. You are allowed to purchase off these lists for the single job order contracts. So, that would be the intention behind that.

Q: Mrs. Briceno asked so why a need to increase.

A: Ms. Morris responded if it doesn't get increased. Then we must hold a board meeting to approve any projects before they can start. We can wait but any project over \$1.M right now as it stands must come to the board for approval before we can start the project and since we only have board meetings once a month that delays our being able to get started. That's why we are requesting an increase, a lot of the projects like the Hurley Ranch Roof project right now are looking like 2.8M for redoing the roof. We do still get quotes from this list to get the best price. It just helps expedite the process we don't have to it just delays our ability to move them forward. If the board would rather have them come before the board if they're over a million before we start the projects, we can do that. Whichever direction you want to go.
