#### VII. SUPERINTENDENT SUMMARY OF CURRENT EVENTS:

**UESD Current Events Summary** 

Good evening, President Doucet and Ms. Briceno,

This evening I will be sharing an update of current events as they relate to our District Goals.

In Goal Area 1: Student Academic Success, our progress over the past several weeks has been on completing state-mandated testing in third through eighth-grade ELA and Mathematics, and fifth and eighth-grade Science. The state assessment, Arizona's Academic Standards



Assessment (AASA), is an on-line assessment that all students in grades three through eight must take. It is administered online; yet requires changes to the daily schedule, meal service, staffing patterns, and is a herculean effort for our schools, particularly our assistant principals, and they are supported by the district academic



services, student services, child nutrition department, and technology teams.

In Goal Area 3: High-Quality Caring Staff: We celebrated our Assistant Principals, Paraprofessionals, and Librarians. Last week we refreshed our District staff shirts, and this Wednesday we treated all staff to an ice cream treat from the Ice Cream Bus! We know that Educator Appreciation Week is formally the second week of May; however, we like to take times throughout the year to celebrate our staff. Thanks to all our partners who make these events possible. Later this evening, you are also going to hear a staffing update from Ms. Avalos about the status of staffing for the upcoming school year.



Goal 4 is focused on securing and effectively managing resources to meet the needs of our 21st Century learners and employees. Our furniture committee reconvened again this week, this time with a focus on classroom spaces. DLR engaged our team in a review of their research about furniture and its impact on the learning environment. The committee members then took time to dream about the classes they would like to see. They were given a worksheet and various formal and informal furniture choices to choose from. They identified what they would like to see in each grade level's classrooms, and for our specialty



classrooms as well. Next steps, DLR will start mocking up classrooms by grade and bringing those designs back for review. In the fall we will engage

more broadly with all teachers to get their input through a model classroom. This allows students, staff, and families to try out the options before we make final choices. Thanks to our team who is helping us envision new and engaging spaces for our students and staff!

We received final approval from School Facilities for the Dos Rios restroom floor demo and repair. We can now schedule the work to start late May/June for the repair of three restrooms at Dos Rios. We will also take this opportunity to change out stalls and refresh the three restrooms as a major project at Dos Rios this summer.

Union ESD was selected by Arizona Department of Education (ADE), for an Average Daily Membership (ADM) Audit. Union ESD has to our knowledge, never received an ADM audit, so it is now our turn. Over the

Board Minutes April 13, 2023 Page 2 course of three months, finishing sometime in June or July, we will be working with ADE's audit team as they review our records for the past three fiscal years, 2020, 2021, and 2022. They will be reviewing our enrollment process, cumulative files, attendance records, and entry and withdrawals. In addition to all of this, they will be reviewing Master Schedules, COVID compliance, and so much more. Thanks to Melanie Block, Shelly Sotelo, and the Technology team for gathering and compiling a lot of the information that we have submitted, and to Ms. Brandon, our school Office Managers, and Principals for the work they will be doing on pulling specific files and records in the next two weeks. During our entrance interview with the auditor this week, they did indicate that should there be significant problems with attendance and enrollment, there could be financial impacts, either favorable or unfavorable to the district. As we proceed, I will keep the Board informed on what we are discovering.

In Goal Area 2: Student Well Being, we are so excited that we have been awarded continuing funding for our school counselors at Hurley Ranch and Dos Rios! The teaching and support that can be provided by having three full time counselors makes an impact on our campuses. You will hear a lot more on Goal Area 2 this evening from Ms. Block, who will update you on the work being done and what is still to come.

In closing, I am encouraging you to save the dates for the eighth-grade promotion ceremonies at Hurley and Dos, May 18<sup>th</sup>. Additionally, we are moving our Kindergarten promotions to Wednesday evening, May 17<sup>th</sup>. Finally, we will be hosting our annual End of Year Celebration at Union Elementary on May 19<sup>th</sup>. You are also welcome to attend. Please let us know if you would like to represent the Board at those ceremonies.
