- A. School Counselor Program Update-Presented by Ms. Melynda Martin Ms. Doucet
  - Q: Mrs. Doucet asked what does tier 3 look like?
  - A: Mrs. Martin responded tier 3 is a referral process that can be done by a parent, or principal. Lifeline PCS will then provide a licensed counselor to do the 1:1 counseling with the student while also working with families on any support services they might need such as family counseling, and sibling counseling.
